Pursuant to Articles 46 and 47 of Presidential Decree 445/2000, Article 61 of Regulation (EU, Euratom) 2024/2509 and to the best of his knowledge at the date of this declaration

- that he/she is not, and has no reason to believe that he/she may be, in any situation of conflict of interest, real or potential, with the Proposing Organization selected and/or with any subcontractors, as well as with entities controlled by or affiliated with the latter;
- that the Implementing Body and any subcontractors have not carried out preparatory activities in relation to the programme and/or the tender;
- that they have no direct or indirect economic, professional, family or corporate relationships with the Proposing organization or any subcontractors that could compromise the transparency, impartiality or independence of the selection and implementation procedure;
- that they do not hold shares, positions or voting rights in companies, entities or consortia linked to the proposing Organization body or subcontractors, nor do they have links with persons who exercise a dominant influence over them;

to have carried out the selection procedure of the OE in full compliance with the principles of transparency, competition, equal treatment and traceability of decisions, as required by current European and national legislation;

that it has adopted, or undertakes to adopt, appropriate internal measures to prevent and manage any conflicts of interest, through the collection and verification of individual declarations by the members of the evaluation committee and the staff involved in the procedure;

to undertake to promptly notify in writing the Agency for Agricultural Disbursements (AgEA), the Ministry of Agriculture, Food Sovereignty and Forestry (MASAF) and the European Commission of any circumstances that may constitute or give rise to suspicion of a conflict of interest during the implementation of the project.

The undersigned also undertakes to promptly notify, and in any case within 30 days of the change, any changes to the content of this declaration and to make, if necessary, a new declaration replacing the previous one.
